-The objective of Code Enforcement is to promote a clean, healthy and safe environment for the citizens of Greenville County. The division works to enforce local ordinances related to environment control and property maintenance.

## Deputy Luke Wilkinson (Community Deputy)

-Community deputies serve as liaisons between the community and law enforcement
Officer's work on community based projects that help raise up the neighborhood.
-If you notice non-emergent issues related to drugs, prostitution, property maintenance etc. and you want them to be addressed a code enforcement officer would work to address these issues.
-Bell Meade does not have a specific community officer assigned to the community but, the division hopes to have someone in place soon.

-Non-profit organization founded in May 2006. The mission of the Organization is to expand opportunities, enhance the quality of life, and the progression of at-risk children, children with disabilities, and their families through various educational recreation, and social programs George Singleton, Upstate Circle of Friends Vice President/COO

The Pavilion will be used to help strengthen resources offered to the organization's charter school (Quest Leadership Academy) and the community as a whole. Quest Leadership Academy- Mr. Singleton reports that 95% of school's students are on free or reduced lunch. Teachers are in need of assistance from community mentors to help with managing students.
